
Term of Agreement

The Service provider will furnish statements and vouchers to the Customer for all such expenses.

Return of Property

Upon the expiry or termination of this Agreement, the Service Provider will return to the Customer any property, documentation, records, or confidential information which is the property of the Customer

Notice

Confidentiality (cont'd.)

The Service Provider may disclose any of the confidential information:

Assignment

This Agreement is a personal one, being entered into reliance upon and in consideration of the personal skill and qualifications of the Service Provider. The Service Provider will not voluntarily or by operation of law assign or otherwise transfer the obligations incurred pursuant to the terms of this Agreement without the prior written consent of the Customer.

Capacity/Independent Contractor

It is expressly agreed that the Service Provider is acting as an independent contractor and not as an employee in providing the Services hereunder. The Service Provider and the Customer acknowledge that this agreement does not create a partnership or joint venture between them. (Federal Tax ID / EIN # 20-4109780)

Entire Agreement

It is agreed that there is no representation, warranty, collateral agreement or condition affecting this Agreement except as expressed in it.

Additional Clauses

The Service Provider does NOT guarantee the (Design/Estimate) beyond the figures provided upon completion of the Agreement. Any cost overruns due to the Customers labor force/project conditions, and/or material increases or errors in original quotations (NOT known by Service Provider) that formed the original Agreement are NOT the Service Providers Responsibility.
